 - a. Publications Committee Lyn Clancy Blast going out this week:

Volume 48, Issue 1 of the Texas Environmental Law Journal is now available for members to access on our section website. Our lead articles in this issue provide reflections on the legal framework of oil spill response after the Deepwater Horizon spill, explore consultant risk under the "all appropriate inquiry" standard of CERCLA, and encourage a zen-based approach to the ethical considerations that may arise when an attorney and a consultant represent the same client. The notes in this issue cover topics that include: the legal regime governing near-earth asteroid mining; lessons learned on increasing wind capacity; and the need for a standard federal policy that could be applied to the settlement of climate-vulnerable communities. And, as always, the issue provides brief updates on a broad range of environmental and natural resources law topics.

- b. Law School Committee -Walt Shelton/Kristen Fancher
 - i. Proposal for Buck Wynne Scholarships -- Increase each award from \$ 1000 to \$ 1500, maximum of 2 awards (\$ 3000) per academic year per school, keep each award for a high classroom grade, and expand the list of eligible courses for each award to include: Environmental Law, Natural Resource Law, Water Law, advanced/Environmental specialty course, and Administrative Law. If a school offers more than 2 of these courses, then the school can choose which 2 courses for the award. This keeps with the intention of the award and also broadens it so

- that more students and schools (hopefully most all of them) benefit from two significant awards per year.
- ii. Summer Internships -- Add one (for a total of 8) and increase the pay (total for 6 weeks) 7 % from \$ 4200 to \$ 4500 each. Our suggestion for addition is either EPA Region 6 (offers a Dallas presence to add to our Houston presence) or LCRA (offers diversity and a different kind of governmental entity experience). An additional internship and increased pay will strengthen this popular and important program.
