I. Welcome and Introductions – David Klein.

David Klein opened the meeting at 11:37am with roll call:

II. Discuss, Consider, and Take Action on the Climate Change Symposium – Nathan Block.

Block updated the Council on the Symposium status. To make the schedule work for an event in April 2022, a call for papers needs to be made soon in order to have paper submissions coming in this fall.

Special Edition of the Texas Environmental Law Journal (TELJ).

To round out a budget for the symposium, the Council may need to cover costs associated with a special edition (i.e., a third issue) of the TELJ. Acevedo and Block estimate that \$6k would cover this but will evaluate further whether a special edition is necessary.

Income.

Registration fees: Without a registration fee, the Council will need to raise \sim \$40k to make the event revenue neutral. Proposal to charge \$75 for the symposium with CLE credit or \$50 for the symposium without CLE credit. CLE credit still needs to be approved. If 50 attendees opt for CLE and 50 attendees do not, the event would generate \$6,250 to offset costs. If capacity for the event is reached and 100 attendees opt for CLE and 100 attendees do not, the event would generate \$12,500.

Sponsorship levels: Proposal for the following sponsorship levels:

Organizing Sponsor: \$5k sponsorship fee, up to 5 free registrations, billing on the program.

Sponsors: \$2,500 sponsorship fee, up to 3 free registrations, billing on the program.

Contributors: <\$2500, billing under "Contributors" on the program.
