

TWCA members are responsible for the state's water supply and development and provide water and wastewater services to the vast majority of Texans.


88th Regular Legislative Session

Big Water Session

- Sunset review of water-related state agencies
- Formation of House Water Caucus
- Budget investments in water infrastructure
 - S.B. 28 \$1 billion (contingent on voter approval)
 - Flood Infrastructure Fund (FIF) -\$625 million
 - State Revolving Fund Match \$125 million
 - Coastal Barrier \$550 million
 - Various TWDB exceptional items for IT and staffing to improve processing of water infrastructure financial assistance



S.B. 28/S.J.R. 75



These funds award loans and grants to mostly political subdivisions for local water/wastewater infrastructure projects



Texas Water Fund

- Umbrella fund that does not directly award funds; TWDB has discretion to move money into other eligible funds/programs
- Legislative priorities for use of this money include:
 - water infrastructure for rural communities and municipalities with a population under 150,000
 - projects with completed permitting
 - water awareness campaign
 - water conservation strategies
 - water loss mitigation
- 25% of the \$1 billion must go to the New Water Supply Fund
- Creation of the Texas Water Fund, and the \$1 billion appropriation, are contingent on voter approval on November 7th



New Water Supply Fund

- Focused on "New Water"
- Eligible projects include:
 - Desalination (marine and brackish groundwater)
 - Aquifer storage and recovery (ASR)
 - Use of produced water outside of oil/gas
 - And transport of water made available by projects above
- These eligible projects generally rely on more innovative technology and are more expensive. These projects are not common in the State Water Plan.



What is New Water?

Senate engrossed eligible projects:

- Water from other states
- Desalination (ocean and brackish groundwater)
- Use of produced water outside of oil/gas

House engrossed eligible projects:

- Water from other states
- Desalination (ocean and brackish groundwater)
- Aquifer storage and recovery (ASR),
- <u>Direct Reuse</u>
- Use of produced water outside of oil/gas

Enrolled/Final list of eligible projects:

- Desalination (ocean and brackish groundwater)
- Aquifer storage and recovery (ASR)
- Use of produced water outside of oil/gas

• Is a new source for drinking water only? Industrial use? Electric generation? Irrigation? Ag?


If focused on innovation, at what point does pervasiveness of a new source remove its newness?

Texas has critical water infrastructure needs


Texas' grade on water, wastewater, and flood infrastucture
